PRIVACY POLICY

The protection, confidentiality and security of your data are important to us. We process this data in accordance to the Data Protection Regulation DSGVO (<u>EUR-Lex - 02016R0679-20160504 - EN - EUR-Lex (europa.eu)</u>). This privacy policy is intended to inform you about the purpose for which your personal data is collected and processed, as well as associated rights.

We process inventory data such as name, address, date of birth and national insurance number; contact data such as email, telephone number and bank data; documentation data; image data such as X-rays as well as health data on previous illnesses, examination categories, medical history sheets, findings etc. Data processing is carried out exclusively based on the legal provisions, in the case of explicit consent only for the agreed purposes.
